Mission Moment: Advocacy, Cont'd

Context: The COVID-19 pandemic has negatively impacted the health and well-being of individuals -especially people of color- who have been historically disadvantaged in the United States. More specifically, the pandemic has exacerbated longstanding inequities in income, food security, and access to affordable, safe, and stable housing. Throughout the pandemic, moratoriums were in place to protect families from eviction and foreclosure. Most of those pandemic policies have ended, leaving millions across the country facing instability and, potentially, homelessness.

What are we doing? One crucial part of Cross-Line's advocacy work involves our leadership of the Safe and Affordable Housing directive of Wyandotte County's Community Health Improvement Plan (CHIP).



In October, Cross-Lines partnered with the Unified Government Public Health Dept. (UGPHD) to host the Wyandotte County Housing Summit, drawing together other housing- focused organizations, community leaders, property owners, and invested parties to learn more about the state of affordable housing in WYCO. Workshop sessions included topics such as, "What is a Community Land Trust?" lead by Community Housing of Wyandotte County, "Tenant's Rights and Responsibilities" lead by the UGPHD and Kansas Legal Services, and "LGBTQ+ Housing" lead by Our Spot KC.



The aim of our work with CHIP and the housing summit is to bring together Wyandotte County housing stakeholders to learn more about current and future initiatives, strategies, and goals to increase access to safe and affordable housing for everyone in Wyandotte County.

In addition to our work with CHIP, Cross-Lines advocates for those we serve by forming positive working relationships with United Government and Health Department officials, Commissioners, and other community organizations.

By building these productive relationships, Cross-Lines strives to help provide better access to services for our neighbors experiencing homelessness, raising awareness around the struggles of being unhoused and helping others understand what measures will make an impact.

Advocacy has always been a part of our work at Cross-Lines. As we look forward to celebrating 60 years of Cross-Lines in 2023, we are hoping to engage with long-time supporters who can speak to our organization's extensive history of working within the community to fight for systemic change.
